It includes the full-text of: Regulations S-K, S-X, S-T; selected rules and forms under the 1933 and 1934 Acts; the Sarbanes-Oxley Act; Industry Guides; Staff Accounting Bulletins; and the Codification of Financial Reporting Policies. New rules featured in this edition include: Article 8 of Regulation S-X, concerning smaller reporting companies; Exchange Act Rule 10b-21, the antifraud rule for naked short selling; and Exchange Act Rule 14a-17, regarding electronic shareholder forums.

The new *2009 Edition* also reproduces Staff Accounting Bulletin No. 110 (valuation of share-based payments), which revised Topic 14.D of the codification. Also included are new Staff Legal Bulletins 3A (1933 Act exemptions) and 14D (shareholder proposals). In addition, a new section provides the SEC staff's Compliance and Disclosure Interpretations for Form 8-K.
