These chapters provide more extensive coverage of business law topics found on the Uniform AICPA exam, making this text the most appropriate BLT version for accounting majors. A CPA supplement is also available with this edition to help students review and prepare for the exam. This text explicitly meets AACSB curriculum requirements. Many features focus on the global, political, ethical, social, environmental, and cultural context of business law. For Critical Analysis questions follow all cases, and now appear within most of the pedagogical features. An appendix to Chapter 1, chapterending Case Briefing Assignments, and a separate text-ending appendix provide ample opportunity for students to learn how to analyze case law. The Personal Law Handbook, available as a separate supplement, covers practical aspects of law such as family law, jury duty, housing law, and other topics. Two new pedagogical features emphasize technology and the Internet. Key content changes include the integration of material on lease contracts and Article 2A throughout all sales chapters, as well as the revision of negotiable instruments material to reflect law based on Revised Articles 3 and 4. Employment/labor law coverage has been streamlined from three chapters in the previous edition to two chapters (Chs. 35 and 36) in the 4th.
